Public notice for expressions of interest for the filling of academic positions by direct call pursuant to art.1, p.9 of the Italian Law 4.11.2005, no. 230

THE RECTOR

HAVING CONSIDERED Law no. 168 of May 9, 1989 as amended and supplemented;

HAVING CONSIDERED Law no. 230 of November 4, 2005, in particular art. 1, paragraph 9, as subsequently amended;

HAVING CONSIDERED Law no. 240 of December 30, 2010;

HAVING CONSIDERED the Statute of the University of Tuscia, issued with the Rector's Decree of July 29, 1996 as subsequently amended;

HAVING CONSIDERED the University Didactic Regulations, issued with Rectoral Decree no. 823/12 of October 16, 2012 as subsequently amended;

HAVING CONSIDERED the Regulations for the discipline of the call for Full and Associate Professors issued with Rectoral Decree no. 190 of March 11, 2016;

HAVING CONSIDERED the resolution of the Board of Directors on July 15, 2025;

HEREBY DECREES

Art. 1

The University of Tuscia, in order to pursue growth of its international profile and strengthen internationalization of its research and teaching strategies, seeks for expressions of interest by direct call for the positions of full professor, associate professor, and fixed-term researcher pursuant to art. 24, paragraph 3, of Italian law no. 240/2010.

Art. 2

This public notice is addressed to:

a) scholars who were awarded specific high-qualification research programs, funded by the Italian Ministry of University and Research (MUR), the European Union (EU), or international organizations in which Italy participates, as identified by this decree following consultation with the Italian National Agency for the Evaluation of Universities and Research Institutes (ANVUR) and the National University Council (CUN);



b) distinguished scholars (*chiara fama*), in possession of at least one of the following requirements according to the provisions of the Ministerial Decree of 15 July 1997: to have occupied, for at least five years, a similar position in foreign universities; to have received international scientific awards; to have held managerial positions in qualified international research institutes for at least five years;

c) scholars permanently engaged abroad in research or teaching activities at university level for at least five years, holding an equivalent academic position in a university or a research institution abroad, according to the correspondences established (between Italian and foreign academic positions referred to in article 18, paragraph 1, letter b), of Law 30 December 2010, no. 240) by the M.D. n. 456, 10 May 2023. The academic position period abroad must be at least five years, held in one or possibly more countries, current at the time of the proposal submission.

The programs referred to in letter a) are defined within M.D. no. 919, 22 July 2022:

A) "Rita Levi Montalcini for Early Career Researchers" – whose grantees are appointed by direct call as fixed-term researcher according to art. 24, paragraph 3, law no. 240/2010;

B) "FIS – Italian Science Fund", whose grantees as "*Principal Investigators*" (PIs), for the purpose of carrying out the program, are appointed by direct call:

- i. as fixed-term researchers according to art. 24, paragraph 3, law no. 240/2010, in the case of winners of "Starting Grant" projects;
- ii. as associate professors or full professors, in the case of winners of "Advanced Grant" projects.

C) "FISA - Italian Fund for Applied Science" program, whose winners as "*Principal Investigators*" (PIs), for the purposes of carrying out the programme, are appointed by direct call as fixed-term researchers according to art. 24, paragraph 3, law no. 240/2010.

D) European Research Council (ERC) programs:

- i. "*Starting Grants*", whose grantees can be appointed by direct call as fixed-term researchers according to art. 24, paragraph 3, law no. 240/2010;
- ii. "*Consolidator Grants*", whose grantees can be appointed by direct call as fixed-term researchers according to art. 24, paragraph 3, law no. 240/2010 or as associate professors;
- iii. "*Advanced Grants*", whose grantees can be appointed by direct call as associate professors or full professors.

E) Marie Skłodowska-Curie Actions (MSCA):

- i. "International Outgoing Postdoctoral Fellowships" or "Individual Postdoctoral Fellowships", limited exclusively to "Global Fellowships", whose grantees can be



appointed as fixed-term researchers according to art. 24, paragraph 3, law no. 240/2010;

- ii. grantees of MSCA of at least two years, falling within the "Postdoctoral fellowships" categories, can be called for the stipulation of a research contract as referred to in art. 22, law no. 240 of 30 December 2010;

F) Human Frontier Science Program Organisation (HFSP):

- i. "Long-Term Fellowships (LTF)" postdoctoral fellowship, whose recipients, provided the fellowship has a duration of at least two years, may be eligible for direct call under art. 22, law no. 240/2010; for the establishment of a research contract;
- ii. "Cross-Disciplinary Fellowships (CDF)" postdoctoral fellowship, whose recipients, provided the fellowship has a duration of at least two years, may be eligible for direct call under art. 22, law no. 240/2010; for the establishment of a research contract.

G) European Molecular Biology Organization (EMBO):

- i. "EMBO Postdoctoral Fellowships", whose recipients, provided the fellowship has a duration of at least two years, may be eligible for direct call under art. 22, law no. 240/2010; for the establishment of a research contract.

Art. 3

Applications must be sent by email talent@unitus.it not later than 60 days after the date of publication of this notice on the Official Notice Board of the University of Tuscia, and must contain the following documents:

- Application form (Annex 1);
- Motivation letter;
- Curriculum Vitae (Annex 2), including a list of publications and brief description highlighting the ten most significant publications from the past ten years;
- Research statement (up to two pages);
- Teaching statement (up to two pages);
- Any documentation that proves correspondence between the Italian and foreign academic positions;
- Certificate of service.

In the case of application pursuant to art. 2 letters b) and c), the application must be accompanied by a verification of employment (also translated into Italian), issued by the current institution to which the candidate belongs, indicating the position held and its effective date.



The expressions of interest presented under notice no. 9685, repertoire no. 100/2024, of March 27, 2024 remain valid. Candidates who have already applied for the previous call can submit a new application or update the previous one.

Art. 4

The direct call procedure is governed by national legislation and by the provisions of the University Regulations for the discipline of the call of Associate and Full Professors - Title V.

The submission of an application for the purpose of this expression of interest does not give any right to admission procedures for accessing the academic position at the University.

Personal data provided by the candidates will be collected at the University of Tuscia. Pursuant to the Legislative Decree 196/2003 (the "Privacy Code") and the EU regulation 679/2016 ("General Data Protection Regulation"), the office in charge of processing data is Human Resources Office. The person in charge of the proceeding, pursuant to art. 4-6 of Law 7/8/1990, no. 241, is the Human Resources Head Office who is entrusted with the management of this proceeding.
