## **CALL FOR PROFESSORS' MOBILITY FROM FOREIGN UNIVERSITIES**

The Ministry of University and Research, in implementation of sub-measure T4 “Transnational initiatives in education”, Investment 3.4 “University teaching and advanced skills” of the National Recovery and Resilience Plan, Mission 4 “Education and research” – Component 1 “Strengthening the provision of education services: from nursery schools to University”, promotes the implementation of transnational educational initiatives (TNE). In the project TNE23-00080 CUP F31I24000320006 “*ProMOting innovation capacity IN the hiGher Education System of Argentina and ITalia through an Action scheme for the MobiLItY And cooperation of UNiversity StudeNts and ProfESSorS*” - “MOVING ITALIANNESS”. A selection process is announced for the assignment of **four (4) mobility contributions for research, learning and collaboration activities from partner universities**. The **mobility must be completed within 28/02/2026** and it involves the foreign partner universities reported in the table of the appendix A.

### **Article 1 – Eligible professors**

Professors/researchers who, at the time of application and during the mobility period, have regularly a working contract at one of the partner universities listed in Appendix A are eligible to participate in the selection process. Failure to meet the aforementioned requirement will result in the inability to carry out the mobility program at the University of Tuscany.

### **Article 2 – Application submission**

Selection is at the counter, i.e. based on the order in which applications are received. Applications must be submitted using the specific Application Form for professors available at

and mandatory documents must be attached until the deadline, set at **12pm (CET) on 8/01/2026**.

The following documentation for professors must be attached to the application:



1. Curriculum vitae;
2. Motivation letter;
3. A valid ID document (preferably valid passport);
4. Invitation letter from University of Tuscia, Mobility and International Cooperation Office;
5. Teaching Mobility Agreement (for teaching activities in topics related to the “Moving Italianness” project) or Training Mobility Agreement for one or more of the following activities: - Olive growing, viticulture and oenology;  
- Precision and forestry agriculture;  
- Precision agriculture and plant protection;

Successful professors who, for any reason, renounce the mobility must promptly notify it within 10 days of notification of selection.

### Article 3 – Duration of mobility and travel and hosting contributions

The professors' mobility period has a maximum duration of **21 days** if coming from the **Universidad de Cuyo (Mendoza, Argentina)**, and **20 days** if coming from the **Universidad Nacional de Córdoba (Argentina)** or the **Universidad Nacional de San Antonio de Areco (Argentina)**. The travel days are excluded from the mobility period.

The maximum financial contribution is defined as indicated in **Appendix A** and is briefly summarised below:

- up to € **5,360.00** (based on expense receipts) for professors from the **Universidad de Cuyo (Mendoza)**;
- up to € **5,200.00** (based on expense receipts) for professors from the **Universidad Nacional de Córdoba** or the **Universidad Nacional de San Antonio de Areco**.

Successful professors:

- can decide to individually arrange their travel and accommodation in Viterbo or request support from the University of Tuscia, CIA, for purchasing airline tickets and booking accommodation;
- should individually arrange their health insurance and travel insurance.

The financial contribution will be recognised as a **total or partial reimbursement**, within the limits indicated above, for all eligible costs incurred.



#### Article 4 – Publication of professors selected

The financial contribution will be awarded progressively, based on the chronological order of application submission, subject to verification of eligibility requirements, until available resources are exhausted. Selected professors will receive notification via e-mail to their institutional address within 10 working days from the submission of their application. Acceptance of the contribution must occur within 10 working days from receipt of the notification, by sending an e-mail to [carlocontardo@unitus.it](mailto:carlocontardo@unitus.it) and to [giorgio.scavino@unitus.it](mailto:giorgio.scavino@unitus.it) with the subject line: "**TNE/PNRR MOVING ITALIАНNESS - Acceptance of the financial contribution**".

Before leaving, the selected teachers will have to sign a Grant Mobility Agreement with the University of Tuscia, template available on the website <https://www.unitus.it/internazionale/studiare-all-estero/progetti-pnrr-tne/progetto-cuia/>.

Failure to accept within the prescribed time frame will result in exclusion from the ranking. In case of withdrawals or non-acceptance by the host universities, any available financial contributions will be reassigned strictly following the order of the ranking.

#### Article 5 – Allowed activities

The following activities are allowed during the professors' mobility period: activities should promote scientific and cultural cooperation between Italian and Argentine universities and contribute to the strengthening of the European Education and Research Area.

Research and teaching activities shall be carried out **within the scientific fields relevant to the TNE-MOVING ITALIАНNESS Project**, as specified below:

- **Olive growing, viticulture, and oenology;**
- **Precision and forestry agriculture;**
- **Precision agriculture and plant protection.**

The mobility period may take place in **February 2026**, as indicated below, maintaining the duration of **21 days** for professors from the **Universidad de Cuyo (Mendoza)** and **20 days** for professors from the **Universidad Nacional de Córdoba** and the **Universidad Nacional de San Antonio de Areco**, **excluding travel days**. **Furthermore, a dedicated event will be organized in the first week of February at the University of Tuscia.**

All the activities must be completed within **28/02/2026**, unless otherwise extended by ministerial provisions.



## Article 6 – Mobility organization and contribution towards travel, food and accommodation expenses

1. Mobility will take place exclusively in **February 2026 until the established deadline of February 28th, 2026**. Within this period, participation is required in the international initiative “Winter School” organised by the University of Tuscia, February 2-7.
2. To confirm the destination and define the teaching/training program to be carried out, professors will receive, at their institutional email address, along with the notification of the scholarship award, an appointment to begin the procedures related to international mobility.
3. It is the full responsibility of the awarded staff to personally take care of the procedures related to the request and preparation of the documentation needed.
4. The mobility period for selected professors must last a minimum of 5 days and a maximum of 14 days, excluding travel days. Before departure, the selected participants must send the completed and signed mobility agreement (financial agreement) to the Office for Mobility and International Cooperation.
5. The maximum daily allowance for accommodation and subsistence expenses, as established by the internal regulations on mission allowances, is € 160.00 per day. The **total maximum financial contribution** that may be granted to each professor — covering travel, accommodation, meals, and other eligible expenses and based on expense receipts — is defined according to the partner university, as summarised below:
  - **up to € 5,360.00** for professors from *Universidad de Cuyo (Mendoza, Argentina)*;
  - **up to € 5,200.00** for professors from *Universidad Nacional de Córdoba (Argentina)* and *Universidad Nacional de San Antonio de Areco (Argentina)*.

The contribution will be provided as a total or partial reimbursement within these limits.

Successful professors:

- can decide to individually arrange their travel and accommodation in Viterbo or request support from the University of Tuscia, CIA, for purchasing airline tickets and booking accommodation;
- should individually arrange their health insurance and travel insurance.
- The financial contribution will be recognised as a **total or partial reimbursement**, within the limits indicated above, for all eligible costs incurred

6. The final contribution will be calculated based on the actual days of mobility, as certified by the certificate of attendance issued by the host university. The start and end dates of the mobility period must correspond, respectively, to the first and last day the grant recipient is physically present at the host institution.
7. The payment procedure will be started upon receipt of a copy of:
  - passport;
  - visa;
  - health insurance;
  - credit form;
  - a complete signed copy of the Grant Agreement.



## Article 7 – Insurance

The University of Tuscia strongly recommends to the professors involved in the exchange to individually provide to sign an adequate insurance coverage for accidents and third-party liability, health insurance and travel insurance coverage during their stay abroad, under the regulations of the host country.

## Article 8 - Personal Data Processing and Confidentiality

Personal data will be processed in compliance with the principles set out in EU Regulation No. 679/2016 on the protection of personal data.
